Benefits for interest free loan amount \$ 50,000(H & W and Unmarried children)
Plus \$ 50,000 pledges paid

1. Complimentary Life Time (5 times use) of Temple Banquet Hall and all related facilities (Subject to availability)
2. Complimentary Life Time (5 times use) of Priestly services at home or at temple (Subject to availability)

Benefits for interest free loan amount \$ 10,000(H & W and Unmarried children)
Plus \$ 10,000 pledges paid

1. Complimentary Life Time (1 time use) of Temple Banquet Hall and all related facilities (Subject to availability)
2. Complimentary Life Time (1 time use) of Priestly services at home or at temple (Subject to availability)

Notes: For Interest Free Loans plus pledges paid option

- For any interest free loans of \$ 250,000 and over, **minimum pledges paid floor will be \$ 100,000** to be eligible for Complimentary Life Time Benefit
- For any interest free loans of less than \$ 250,000, **minimum pledges paid floor will be \$ 50,000**. Complimentary life time benefit in this case will correspond with the loan amount given in multiples of \$ 10,000
- For any interest free loans of less than \$ 50,000, **minimum pledges paid floor will be \$ 10,000**. Complimentary life time benefit in this case will correspond with the loan amount given in multiples of \$ 10,000
- Interest Free Loan alone by itself will not be eligible for Complimentary Life Time Benefit
- Any one interested in giving just loan only, will be given 3% interest only, which the lender can then chose to get paid for or donate back to temple
- Payback of all loans will start as soon as enough loan amounts is collected from donors to payoff temple mortgage balance of \$2,995,000. Payback will be in proportion to the total loan outstanding
